APPLICATIONS FOR 2016 GAMING PERMITS AVAILABLE OCTOBER 1, 2015.

1. Beginning October 1, 2015 you may apply for your 2016 Charitable Gaming Permit through Online Permits and Licensing (OPAL) at: www.tax.alaska.gov/programs/online.aspx
2. Application forms will also be available at our website beginning October 1, 2015: www.tax.alaska.gov/gaming
3. **The deadline to apply for, renew, or amend a 2016 gaming permit is December 15, 2015.** No applications, renewals, or amendments will be accepted after this date.
4. If you miss this deadline, you may apply, renew, or amend through Revenue Online beginning the week of February 22, 2016 at <https://online-tax.alaska.gov>.

DEADLINE TO FILE 2015 ANNUAL FINANCIAL STATEMENT EXTENDED TO APRIL 14, 2016.

1. The deadline to file your 2015 Annual Financial Statement (AFS) has been automatically extended from March 15, 2016 to April 14, 2016. You do not need to request an extension and no extensions will be granted beyond April 14, 2016. You will be required to file your AFS through Revenue Online.
2. This extension does not apply to your 2015 fee; if you owe a fee, it is due March 15, 2016 and must be paid through Revenue Online to avoid interest and penalties.

DEMONSTRATION OF REVENUE ONLINE.

Effective February 22, 2016 we will convert to an online tax system called Revenue Online. All permittees will be required to file reports, make payments and renew permits online.

Please plan on attending an upcoming demonstration of Revenue Online. Each session will last 30-45 minutes depending on the number of questions the group has. If you are unable to attend a demonstration, a presentation will be made available at our website that you can view at your convenience.
